Reference is made to (i) the announcement of Future Machine Limited (the “**Company**”) dated 23 July 2025 in relation to, among others, the proposed Rights Issue on the basis of one (1) Rights Share for every two (2) existing Shares held by the Qualifying Shareholders on the Record Date; and (ii) the announcement of the Company dated 7 August 2025 in relation to the delay in despatch of prospectus (collectively, the “**Announcements**”). Unless the context requires otherwise, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

FURTHER DELAY IN DESPATCH OF PROSPECTUS

As disclosed in the Announcements, a Prospectus (the “**Prospectus**”) containing, among other things, further information on the Rights Issue and the transactions contemplated thereunder will be despatched to the Shareholders on or before Monday, 25 August 2025.

As additional time is required for the Company to prepare and finalise the information to be contained in the Prospectus, it is expected that the despatch of the Prospectus will be postponed to a date falling on or before Friday, 12 September 2025.
